C I R C U L A R

Subject: Implementation of the recommendations of 7th CPC-Additional HRA for civilian employees of the Central Government serving in the states of NER, Anandaman & Nicobar Islands, Lakshadweep Island and Ladakh - regarding

Consequent upon revision of the rates of HRA granted to the Central Government employees on implementation of the recommendations of 7th CPC vide O.M. No.2/5/2017-E-II (B) dated 07.07.2017, the Ministry of Finance, Department of Expenditure vide their O.M. No.28/1/2017-E-II(B) dated 19.07.2017 modified the Ministry's O.M. No.11016/1/E.II(B)/84 dated 29.03.1984 and O.M. No.2(19)/E.II(B)/2008 dated 02.01.2009 stipulating that additional HRA shall be granted to the civilian employees of the Central Government posted to states of NER, Anandaman & Nicobar Islands, Lakshadweep Island and Ladakh, who leave their families behind at the old station at revised rates as per O.M. No.2/5/2017-E.II(B) dated 07.07.2017.

According to the above modification of Ministry of Finance, Department of Expenditure O.M. No.2(19)/E.II(B)/2008 dated 02.01.2009 the following decisions are made:

- a) In case of civilian employees of Central Government transferred to and posted from a date prior to 01.01.2016, who left their families behind at the old duty station, the HRA of the old duty station will be calculated w.e.f. 01.07.2017 on the pre-revised pay as on date of transfer but the percentage rates of HRA effective from 01.07.2017 as per O.M. No.2/5/2017-E.II(B) dated 7th July, 2017 will apply w.e.f. 01.07.2017, which has also been clarified by the Ministry of Finance, Department of Expenditure O.M. dated 19.07.2017.



- b) In case civilian employees of Central Government transferred to and posted from a date on or after 01.01.2016, the HRA of the old duty station w.e.f. 01.07.2017 will be calculated on the revised pay as on date of transfer with the percentage rates effective 01.07.2017 as per O.M. No. 2/5/2017-E.II(B) dated 7th July, 2017, which has also been clarified by the Ministry of Finance, Department of Expenditure O.M. dated 19.07.2017.

These orders will not be applicable to such employees who were transferred out of NER, Anandaman & Nicobar Islands, Lakshadweep Island and Ladakh before 01.07.2017.

These orders shall take effect from 01.07.2017.


