MEMORANDUM

On the basis of the recommendations of the Departmental Promotion Committee, the President is pleased to approve the appointment of Shri S. C. Director General (Geology) at his place of posting on promotion **within thirty (30) days from the date of issue of this Memorandum** failing which offer of promotion will be liable to be cancelled without further intimation. Director General (Geology) may be forwarded to this office through proper channel for issuance of Notification.


